The following representations and conditions apply to taking guardianship of the below listed animals. Please read carefully as by signing this document you indicate you understand and agree to comply with each item listed.

- \_\_\_\_\_ There is no guarantee of health or temperament of the animal you are acquiring, and you release LIBR from any and all claims of liability.
- \_\_\_\_\_ I agree to provide the animal with covered shelter from the elements, and will not prevent or deny the animal access to this building.
- \_\_\_\_\_ I agree to provide the animal with fresh water and food daily.
- \_\_\_\_\_ If the animal at anytime receives notable injury or is suffering, I agree to trap the animal and get it proper veterinary care – including humanely administered euthanasia if necessary.
- \_\_\_\_\_ I understand that the animal has had its vaccinations, has been spayed/neutered and has been tested negative for Feline Leukemia and Feline AIDS. I agree that I am responsible for additional vaccinations as is warranted.
- \_\_\_\_\_ I agree that any additional animals I will be adding, from whatever source, must be vaccinated and spayed/neutered prior to their release.
- \_\_\_\_\_ I agree that I will treat the animals humanely and prevent harm or cruelty caused by humans.
- \_\_\_\_\_ I have received the Colorado Department of Agriculture rabies prevention flyer, medical records and Acquisition Record for my animal as part of my adoption packet.
- \_\_\_\_\_ I have received KNOWN injury, illness, or abnormality (health or behavioral) notes from the rescue at the time of adoption.
- \_\_\_\_\_ I understand that studies show 25% or more of feral cats will not stay on the property where they are released, and I agree to accept or legally transfer responsibility for these animals in the event they relocate to a neighboring facility. I agree that if I transfer responsibility that I will make sure the new guardians will treat the animals humanely and with the same expectations as are outlined here.

In consideration of my acceptance of assuming ownership the aforementioned animal from LIBR, I hereby release and discharge, indemnify, defend and hold harmless, LIBR and its Board of Directors, its volunteers, agents, members and other individuals and entities contributing support, from any liability for damage to or loss of personal property, sickness, injury from whatever sources, legal entanglements, imprisonment, death, loss of money, etc. which may occur as a result of my adoption. My participation is strictly voluntary and I assume all risks inherent and unforeseen. I have read and fully understand the terms and conditions of this release. I further understand that these provisions are binding and enforceable by law.
